NSGC Membership

• As of March 31, 2009 NSGC had 2,181 members in all categories that had renewed for 2010. Of these, are 1,887 practicing genetic counselors. Membership renewal for 2010 is ongoing.

Board of Directors

- The NSGC Board of Directors met February 19-20, 2010 in Chicago, IL. During this meeting the Board conducted business and initiated work on a new vision statement. that was released on April 23, 2010.

New in 2009, the AEC included a day of preconference symposia allowing for in-depth coverage of specific topics.
- The 2010 AEC is scheduled for October 14-17, 2010 in Dallas, Texas.

- NSGC liaison Deb Doyle and future liaison Leslie Cohen attended the AMA CPT Editorial Panel Meeting in February 2010 in Orlando, FL.
- Liaison Rhonda Schonberg represented NSGC at the National Advisory Council for Human Genome Research (NACHGR) meeting held in February 2010 in Washington DC and provided NACHGR members with a summary of NSGC activates.
- NSGC was represented on the Institute of Medicine Roundtable on Translating Genomic-Based Research for Health by past President, Cathy Wicklund. NSGC President Liz Kearney accompanied Cathy at the March 2010 meeting in Anaheim, CA.
