- As of July 31, 2017, NSGC had 3,528 members.

- NSGC Past Presidents Jennifer Hoskovec and Cathy Wicklund are representing NSGC to the Genetic Counselor Workforce Working Group (WFWG), a collaborative effort of the US genetic counseling organizations to enhance the capacity of the current genetic counselor workforce and the growth of the profession moving forward.
