## **NSGC Membership**

- As of September 30, 2015, the end of the 2015 dues reporting period, NSGC had 3,174 members.
- Dues renewal is ongoing for the 2016 membership year.

- The next in-person Board meeting is scheduled for February 5-6, 2016 in Chicago, IL.

## Education

- NSGC is approved as a provider of CEUs for genetic counselors. Please contact Molly McGinnis, NSGC Continuing Education Coordinator, with any questions.
- The 2015 Annual Education Conference (AEC) was held October 21-24, 2015 in Pittsburgh, PA.
   The program has been finalized. Conference information is available on the <u>NSGC website</u>.
- The 2016 AEC will be held September 28 October 1, 2016 in Seattle, Washington
- NSGC has many online educational opportunities available for additional continuing education.
   These cover a variety of topics such as family history, coding and billing and cultural competency.
   Additional information on these and other course is available to the public on the NSGC website.
- · Recent courses of interest include:
  - NSGC launched the online course, <u>Personalized and Precision Medicine</u>, in June 2015. This course is focused on professional development for genetic counselors and genetics professionals.
  - o In 2014 NSGC launched the educational series, <u>Business Foundations for Genetic Counselors</u>. This series currently includes two courses, <u>Insurance and Credentialing 101</u> and <u>Billing and Coding</u>. Each course includes an online didactic module, ongoing webinars, resource materials and a course participant discussion forum. Courses were developed for genetic counselors, but contain information of interest for billing and medical staff offices at institutions employing genetic counselors. # Government Relations and Advocacy

- Several NSGC position statements are in development or revision. All NSGC position statements are available on the NSGC website.
- NSGC is pursuing legislation that will recognize genetic counselors as Medicare providers.
- NSGC has provided ongoing guidance to states pursuing licensure and writing licensure rules and regulations:
  - Issuing licenses: CA, CT, DE, IL, IN, MA, ND, NE, NJ, NH, NM, OH, OK, PA, SD, TN, UT, WA
  - Passed bills/in rulemaking: HI, ID, VA
  - 20 additional states have bills introduced or in preparation
