September 24-25, 2018

The Open Session of the 84th meeting of the National Advisory Council for Human Genome Research (NACHGR) was convened at 10:00 AM on Monday, September 24, 2018 at the 6700B Rockledge Conference Center in Bethesda, Maryland. Dr. Eric Green, Director of the National Human Genome Research Institute (NHGRI), called the meeting to order.

DIRECTOR'S REPORT

REPORT – *Genomics and Society Working Group Annual Report*Dr. Jeffrey Botkin provided an update on the Genomics and Society Working Group (GSWG) of NACHGR. The Working Group provides advice about the ELSI Research Program and activities of NHGRI's Division of Genomics and Society. The May 2018 meeting report did not generate any specific recommendations for NACHGR, but other Council members suggested evaluating the ethical, legal, and social implications of polygenic risk scores at future GSWG meetings.

GSWG will host a strategic planning session for NHGRI at the <u>American Society for Bioethics and Humanities Meeting</u> on October 19, 2018.

REPORT – National Academies of Sciences, Engineering and Medicine: *Returning Individual Research Results to Participants: Guidance for a New Research Paradigm*Dr. Jeffrey Botkin gave a summary of the NIH co-sponsored report by the National Academies on returning individual research results to participants. Two Health and Human Services regulations – Clinical Laboratory Improvement Amendments (CLIA) and Health Insurance Portability Accountability Act (HIPAA) – provide contradictory guidelines. The charge to the committee generating the report was to determine if/when it is appropriate to return individual research results to research participants by reviewing current practices, examining the evidence of benefits, risks and cost, and considering the ethical, social and regulatory aspects associated with returning results.

CONCEPT CLEARANCE – Human Genome Reference Center and Related Concepts

Dr. Adam Felsenfeld presented five concepts that would constitute a proposed Human

Genome Reference Program. The Program would provide new levels of support for the Human

Genome Reference by: updating reference builds and representations of the human genome;

adding new high-quality human genome sequences; developing bioinformatic tools for the clinical and basic science communities; and developing education and outreach activities.

REPORT – *Genomic Medicine Working Group Activities in 2018*Dr. Teri Manolio gave the annual report of NACHGR's Genomic Medicine Working Group (GMWG). The GMWG advises NHGRI on the research needed to evaluate and implement genomic medicine. GMWG is now planning the 11th Genomic Medicine meeting; this one will focus on the role of employers as the primary payers for genomic medicine.

Council Members expressed interest in NHGRI's implementation of NIH's Strategic Plan for Data Science. Dr. Plon requested an update on the Variation, Function, and Disease supplements (approved at the May 2018 NACHGR meeting) at either the May or September

2019 Council meetings. Dr. Chung requested an update on the wrap-up and lessons learned from the Newborn Sequencing in Genomic Medicine and Public Health (NSIGHT) program at a future Council meeting. Council suggested two topics for scientific presentations at a future Council meeting: the value and utility of polygenic risk scores and future approaches for high-throughput functional genomics in the context of NHGRI's new Strategic Plan.

REVIEW OF APPLICATIONS

2/12/2019

In the Closed Session, the NACHGR reviewed 146 applications, requesting \$47,168,491 (direct costs). The applications included: 96 research project applications (R01, R03, R15, or R21); 1 research center application (U54); 8 cooperative agreement applications (U01 or U24); 6 career development or career transition applications (K99/R00, K01, or K08); 6 research education applications (R25); 3 conference applications (R13); 15 SBIR Phase I applications (R43); 9 SBIR Phase II applications (R44); and 2 STTR Phase 1 applications (R41). A total of 146 applications totaling \$47,168,491 were recommended by the NACHGR.
