- As of June 25, 2016, NSGC had 3,103 members.

# **Government Relations and Advocacy**

  - Issuing licenses: CA, CT, DE, ID, IL, IN, MA, ND, NE, NJ, NH, NM, OH, OK, PA, SD, TN, UT, WA
  - o Passed bills/in rulemaking: HI, MN, VA
  - o 20 additional states have bills introduced or in preparation
