What is ELSI?

- "Ethical, legal, and social implications"
- A lens, perspective, or framework used to assess, examine or evaluate the field of genetics and genomics
- A research program established at NIH in 1990 as part of the U.S. Human Genome Project



History of the ELSI Congress

- NHGRI ELSI Research Program supports empirical, analytical, and conceptual research
- No society or conference encompasses the field of ELSI research
- 6 ELSI Congress meetings held since 2001
- Most recent meetings (2020, 2022 and 2024) supported by a U13 conference grant



ELSI Congress Goals

- 1) provide ELSI researchers a dedicated conference to come together and share research findings;
- 2) encourage collaboration with particular attention to trainees and early career scholars; and
- 3) provide a highly accessible format to ensure participation from a broad range of groups



Key Features

- Biennial 2026, 2028 and 2030
- Multi-day research conference, 300 400 attendees
- Mix of session formats
- Hybrid meeting to maximize participation
- Organizing Committee including awardee, NHGRI ELSI staff, and representatives from across the ELSI research community

Grant Mechanism – U13

- NIH conference grants have several key differences from research grants
- Read the funding opportunity carefully! There are several requirements specific to conference grants



Cooperative Agreement

- Substantial NIH programmatic involvement anticipated.
 - To support and stimulate activities by involvement in or working jointly with the recipients in a partnership role.
 - Not to assume direction, prime responsibility, or a dominant role.
- Specific terms listed in funding opportunity



Eligibility

- Domestic organizations located in the US or in US territories are eligible to apply
- Foreign components are allowed
- All organization types are allowed

Cover Letter – Permission to Submit

- All applicants MUST contact NHGRI by 10/8/24 to obtain a permission to submit letter
 - Email Nicole (lockhani@mail.nih.gov)
- This letter MUST be included with the application as a cover letter

Applications that do not include a permission to submit letter will be withdrawn



Research Plan/Conference Plan – 6 pages

- Main body of your application where you will detail your plans for the conference
- 4 Key Areas to describe:
 - Conference Overview
 - Conference Planning and Organization
 - Family Care
 - Planning for Future Meetings



Conference Overview

Should describe the following:

- Objectives, session formats, and logistical arrangements
- Sessions for trainees and early career scholars
- Process for invitation, submission, review and selection of <u>abstracts for presentation</u>
- Process for invitation, submission, review and selection of <u>travel awards</u>



Conference Planning and Organization

Should describe the following:

- Organizing Committee
- Plans for publicizing the conference and resources for attendees
- Plans to maximize participation using in-person and virtual content
- Plans to maximize the accessibility of the ELSI Congress for people with disabilities



Family Care

- Describe plans to identify resources for childcare and other types of family care
- Information should allow attendees to arrange for family care as needed



Planning for Future Meetings

- Funding opportunity for support of 3 biennial conferences in 2026, 2028 and 2030
- If requesting multiple years of support, provide information on future years including:
 - Conference topic(s)
 - Tentative dates, locations, and attendees
 - Plans dependent upon the outcome of the first year's conference or developments in the field
 - Plans to assess and evaluate each conference



Diversity Plan – 1 page

- Include in the Other Attachments section
- Must be named "DiversityPlan.pdf"
- Describe plans to enhance diversity by broadening the participation of individuals from diverse backgrounds, including those from underrepresented groups

Applications that do not include a diversity planwill be withdrawn



Dissemination Plan – 1 page

- Include in the Other Attachment section
- Must be named "DisseminationPlan.pdf
- Describes how research presented at the Congress will be preserved and disseminated
- Variety of possible approaches
- NHGRI encourages disseminating research findings and products via publicly accessible platforms such as the Center for ELSI Resources and Analysis



Resource and Data Sharing – Not Applicable



- Resource Sharing Plan not applicable, do not include
- Data Management and Sharing Plan not applicable, do not include

Awards

- NHGRI intends to fund 1 award
- Application budgets are limited to \$350,000 direct costs in a year in which a Congress is held
- Applications for up to five years in duration will be accepted to support ELSI Congress meetings in 2026, 2028, and 2030.



Budget Highlights

- Facilities and Administrative (F&A) costs are not allowed
- Provide a narrative justification for each personnel position
- Pay careful attention to allowable and non-allowable costs outlined under R&R Budget in Section 4



Registration Fees

- Registration fees limited to \$500 per meeting for inperson attendees and \$100 per meeting for virtual attendees.
- Applicants should consider establishing reduced registration fees for trainees, researchers from resource-limited institutions, researchers from lowand middle-income countries and/or others

Peer Review

- NHGRI will convene an expert review panel specifically for the ELSI Congress applications, likely ~March 2025
- Section V of the Funding Opportunity includes review criteria that will be used to evaluate your application
- Include sufficient detail in your application to allow reviewers to assess each criterion
- Scores and summary statement provided following review
